

CONTINENTAL LIFE CYCLE IVYBRIDGE RETREAD TYRE LIMITED WARRANTY

BRIEF INTRODUCTION:

Continental Life Cycle (hereafter known as CLC) Ivybridge producing Bandvulc & ContiRe branded tyres is a professional retread tyre manufacturer. With its technically advanced production and test equipment, only quality materials are sourced, supplied and used in the manufacture of Re-treads. CLC Ivybridge offers the most complete retread product line and reliable quality retread tyres in Europe.

The following limited warranty contains certain rights and obligations that pertain to Bandvulc and other off-take branded re-treads. Please review these rights and obligations carefully.

This limited warranty covers Bandvulc and other off-take branded retread tyres provided by Bandvulc in Europe.

All tyres re-treaded at CLC Ivybridge are identifiable by the “E² 109R 009011” marking.

WHO IS ELIGIBLE?

You are eligible for the benefits of this limited warranty if you are the original purchaser or authorized agent of the original purchaser of Bandvulc and other off-take branded re-treads bearing complete serial numbers.

WHAT IS COVERED AND FOR HOW LONG?

This limited warranty covers all retread tyres produced & provided by CLC Ivybridge for adjustment on or after September 30th 2019. The limited warranty is in effect for 5 years commencing on the date of purchase. If proof of purchase date is not available, the date of manufacture indicated on the serial number will be used as the warranty commencement date.

WHAT IS NOT COVERED BY THE WARRANTY

- Tyres which were submitted for claims more than 5 years after the date of purchase or manufacture.
- Tyres damaged by road hazard injuries or damages caused by obstacles or debris, such as cutting/chipping, punctures, (whether repairable or not), snags, bruises, tears or impact breaks.
- Tyres damaged by accident, corrosion, vandalism, fire or nature.
- Tyres damaged by improper mounting/dismounting procedures, improper inflation or other maintenance abuses.
- Tyres damaged by continued operation while flat or severely under inflated.
- Tyres damaged by improper application of tyre size and / or specification.
- Tyres damaged by use of sealants and fillers.
- Tyres not manufactured at CLC Ivybridge.

COVERAGE:

If any retread branded tyre provided by CLC Ivybridge and covered by this limited warranty becomes unserviceable due to a covered warranty condition, such tyre will, (at the option of CLC Ivybridge) be either;

- repaired or replaced with a comparable new retread tyre – with credit applied below*
- Credit applied below*

Amount of Credit to the Customer for Workmanship and Material Condition

*Percentage calculation of tread depth remaining.

WARRANTY LIMITATIONS:

The limited warranty is applicable to the original purchaser and is not assignable to subsequent purchases.

All obligations or liabilities for incidental or consequential damages are hereby excluded.

No dealers, agents, or representatives have the authority to make or imply any representation, promise or agreement which in any way varies or extends the terms of this warranty.

Any CLC Ivybridge branded retread tyre, no matter how well manufactured, may fail in service or otherwise become unserviceable due to conditions beyond the control of the manufacturer. This limited warranty is under no circumstances a representation that a tyre failure cannot occur.
